The meeting was started at 04.00pm. At the outset Chairman welcomed all the distinguished members of the BoG and expressed his gratitude for their contributions and active participation in the meeting of the Board.

The following agenda were deliberated:

BoG/08/2024/01 Confirmation of the previous (07th) meeting minutes of BoG.

The minutes of the previous 07th meeting were read and confirmed as no comments were received earlier and no comments were offered on the floor by any member.

BoG/08/2024/02 Action taken on the decisions of the previous (07  $^{th}\!)$  meeting of the BoG.



Actions taken on the decision made on 07<sup>th</sup> meeting of the BoG were noted by the Board of Governors.

BoG/08/2024/03 To approve the budget of infrastructure development worth Rs.  $90,\!00,\!000$  for additional courses.

Director Dr. Prashant Warke put the budget of Infrastructure development before committee as suggested in previous meeting by members. The committee reviewed the proposed budget allocated for infrastructure development. The proposal included details of planned construction of new floor, renovation, and modernization of existing facilities, such as classrooms, laboratories. Members discussed the financial feasibility, timelines, and expected outcomes of the proposed developments. The committee emphasized the importance of ensuring quality standards, adherence to safety regulations, and sustainable practices in all phases of implementation.

After due deliberation, the committee unanimously approved the proposed budget for the infrastructure development of the college and BOG has recommended the Management of Godavari Foundation to allocate the fund of Rs. 90,00,000 for Infrastructure Development.

### BoG/08/2024/04 To discuss and approve new CCTV installation

The committee discussed the proposal for the installation of new CCTV cameras across the college campus to enhance safety and security for students, staff, and property. The proposal included details regarding the number, technical specifications, cost, and maintenance requirements. Members reviewed the current security arrangements and identified areas requiring improved surveillance, such as entry and exit gates, corridors, laboratories, parking areas, and other common spaces.

After careful consideration, the committee approved the installation of new CCTV cameras as proposed.
