B₀G/09/2025/03 To review the work of infrastructure development

Director Dr. Prashant Warke gives information about infrastructure development of college.

1. Additional Construction for Autonomy:

• Construction of two new floors with all requirement of Autonomous Institute is in Future Stage.

2. Library and Learning Resources:

- Addition of new books, including e-books and online journals.
- Installation of new computer workstations for research and learning.

3. Sports:

• Upgrading indoor and outdoor sports facilities & gymnasium equipments.

4. Administrative and Support Facilities:

- Installation of security systems, including CCTV cameras and access control.
- Improved of parking spaces and campus pathways for safety and accessibility.

BoG/09/2025/04 To accord approval on purchase of new computers

Dr. Neelima Warke told the members about computer lab in order to upgrade and modernize its existing infrastructure. Need of purchase of new computers to enhance the technological infrastructure of the college. This aims to provide students, faculty with up-to-date computing resources. The new computers will replace outdated equipment, ensuring

smooth operation of software applications, faster processing speeds, and improved overall efficiency in academic tasks. It will also contribute significantly to maintaining the college's standards of education and keeping pace with modern technological requirements.

The committee members approved the proposal and instructed the purchase of new computers for college.

BoG/09/2025/05 To increase the intake of MCA from 60 to 120 with effect from 2025-2026

Director Dr. Prashant Warke has suggested to the committee members that there is a significant demand for the MCA course, as evidenced by the large number of inquiries and applications received by the college. To accommodate this growing interest and provide opportunities to more eligible candidates, it was proposed to increase the intake capacity of MCA course from 60 to 120 seats.

After discussion, the committee members agreed with the proposal and authorized the college to proceed with increasing the MCA intake to 120 students.
